B. APPROVAL OF PURCHASES

1. Approval to purchase two 2020 Chevy Tahoe PPV Police Interceptor vehicles for \$38,548 each, totaling \$77,096 for both; and one 2020 Chevy Tahoe PPV vehicle for \$38,048, from Miles Chevrolet, 150 W. Pershing Rd., Decatur, IL 62526. The purchase price is through the State of Illinois Purchase Program. Two vehicles will be purchased in the current fiscal year (FY 19/20), and the third in next fiscal year (FY 20/21). All will be paid for through the Equipment Replacement Fund.
2. Approval to purchase a Zetron IP Fire Station Alert System from Mercury Systems, 123 Ambassador Drive, Suite 151, Naperville, IL 60540, for the Hillside Fire House at a cost of \$11,789.01. This will be integrated with the new Zetron Max-FSA Transponder System.

3. Approval to purchase new emergency telephones from Mercury Systems, 123 Ambassador Drive, Suite 151, Naperville, IL 60540, for the Hillside Fire House at a cost of \$6,138.68. These will be tied into the new Zetron System which will allow us to eliminate a phone line and save the Village about \$500 per month.
