# MINUTES FOR THE BOARD-OF-A-WHOLE MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES AT THE MUNICIPAL COMPLEX, 425 HILLSIDE AVENUE, HILLSIDE, IL 60162 AT 7:30 P.M. ON MONDAY, MARCH 11, 2024

#### **PUBLIC COMMENT:**

Mayor Tamburino opened the Public Comment section of the meeting.

Roger Romanelli, 4406 Madison, asked if hotel taxes could be used for something other than tourism. He said other municipalities such as Springfield and Naperville use hotel taxes for things other than tourism. He also asked for an explanation on how hotel taxes were reported.

As there were no further comments Mayor Tamburino entertained a motion to close the Public Comment portion of the meeting.

So moved by Trustee Johnson, seconded by Trustee Watson. All voting aye, motion carried.

Mayor Tamburino asked Administrator Pisano to comment on the hotel tax. Administrator Pisano reported some of the communities in DuPage county petitioned the state and had the state statute changed where they could utilize the hotel/motel tax for things beyond tourism.

Mayor Tamburino said the Village of Hillside belongs to the Oak Park Tourism Bureau and will be contributing to them this year. He said we have the right to petition the State, but could only spend 25% of that on the petition. Administrator Pisano added that we would be required to collect the tax.

Mayor Tamburino talked about Home Rule. There were two reasons we went Home Rule was to institute any form of a sales tax rebate program from our coffers to new businesses that come in and Zoning, which was the primary reason.

Mayor Tamburino then explained if the Governor eliminates the grocery tax then municipalities need to look for other funding to make up the loss in sales tax.

Mayor Tamburino extended the sympathy of the Village Board and the Village of Hillside to the family of Lucas Knudsen, thirty-one year old member of the Emergency Management Agency (EMA) who recently passed away in his sleep. He also thanked EMA, the Police and Fire Departments for their support to the Knudson family.

#### VILLAGE CLERK:

Clerk Gould reported Mail Ballot applications for the March 19, 2024 Primary Election are available at the front counter in the Village Hall and online at cookcountyclerk.com. Completed applications must be received at the Cook County Clerk's Office by Thursday, March 14, 2024.

Clerk Gould also reported Early Voting continues until March 18<sup>th</sup>. The nearest polling places to Hillside are the Village of Bellwood, 3200 Washington or Village of Melrose Park, 1000 N. 25<sup>th</sup> Avenue.

#### VILLAGE ADMINISTRATOR:

Administrator Pisano reported he would like to offer a clarification and read this into the minutes because it was incorrectly stated at the last meeting by Mr. Romanelli, who cited that the Village of Hillside inaccurately or inappropriately destroys Village records. He continued saying, I think it's important for everyone to understand what the Village does and does by law under state statute and under the requirements provided herein.

He then read an e-mail that was sent back to Mr. Romanelli, which stated that your concern has been forwarded over to the Illinois State Archives Record Management Division by its field staff for further clarification. The Village of Hillside falls under application for authority to dispose of Cook County Records #96-004C, which had a record series added, approved by Cook County Local Records Commission, on February 14<sup>th</sup>, 2023. This was item number 142, recordings of minutes, audio and video, which allows the Village of Hillside to destroy or dispose of these records in compliance with Local Records Act 50 IL CS2O5.

Disposal certificates were filed on 11/30/23 for records made 2024 and on 2/18/23, for records made between 2005 and 2023.

This is the important part Mayor and I'd like everyone to understand what our Clerk and Clerk's Office has been able to do for the village. As of this day, the Village of Hillside is fully compliant with item number 142 Recordings of Minutes with the Act. These disposals are in compliance and reflect good administration of the village government under Local Records Act and the Open Meetings Act.
