MINUTES OF THE BOARD-OF-A-WHOLE MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF HILLSIDE HELD IN THE MUNICIPAL COMPLEX, 425 HILLSIDE AVENUE, HILLSIDE, COOK COUNTY, ILLINOIS, ON MONDAY, OCTOBER 10, 2022

The meeting was called to order at 7:30 P.M. by Mayor Joseph T. Tamburino. The following members responded as present at roll call:

PUBLIC COMMENT

Mayor Tamburino opened the Public Comment section of the meeting.

Roger Romanelli, 4406 Madison, brought in a visual aide along with his neighbor, Julio Aguirre to hold. Mr. Romanelli said they had some concerns about following the laws of our state and again stated, his concern about high taxes.

He asked why the meeting being held this Friday is only for anyone over 60 years of age. He said the Open Meetings Act was being violated by not allowing anyone under 60 years of age to attend the meeting.

Mr. Romanelli then brought up what he said was with election interference. He said that on the visual aide he brought there was a picture of State Representative Welch along with Hillside Police Officers that were on duty, inside a government building, who, in his view, were promoting Representative Welch's campaign.

Mr. Romanelli said the Police Officers should be assisting the public not posing for illegal political photos.

Mr. Romanelli then said there was a public meeting held on May $14^{\rm th}$, where Representative Welch's wife passed out political flyers on the building grounds. He again said this was election interference.

Mr. Romanelli then asked the Mayor, why the meeting on Friday is only for residents 60 years of age or older and why people under 60 years of age are being discriminated against?

Julio Aguirre, 752 Rohde, said when he moved to Hillside 7 years ago, his taxes were \$4,200.00 and now his taxes are \$7.000.00. He also asked why he can't attend the meeting on Friday. He said he doesn't know the laws, but does feel discriminated against.

Mayor Tamburino invited him to come in with his tax bill so he look at it. Mr. Aguirre said he doesn't understand why his taxes are \$7000.00 and his neighbor pays \$650.00. Mayor Tamburino said that was difficult to answer without seeing the bill.

There was discussion at this time between Mr. Romanelli and Mayor Tamburino. Mayor Tamburino said the last time he brought someone in with high taxes the person did not apply for all the benefits he was entitled to receive. Mr. Romanelli told the Mayor he could not slander him. After much back and forth discussion Mr. Romanelli sat down.

Mayor Tamburino said to Mr. Aguirre he wants to look at the tax bill to be sure that all of the exemptions are being applied. He explained that when we passed our property tax levy, we passed a zero increase. He also said the area that Mr. Aguirre lives in has new taxes for the new school that was built.

Mayor Tamburino also said he would be happy to go to the Assessor's office together with him.

Mr. Aguirre again asked about being able to attend the meeting on Friday. Mayor Tamburino said he would talk about that in a few minutes.

Again, there was conversation between Mr. Romanelli and Mayor Tamburino. Mr. Romanelli said it was wrong for Mayor Tamburino to attack him personally. Mayor Tamburino said he was not attacking him. Trustee Watson said to Mr. Romanelli that Mayor Tamburino did not even bring up his name, it was Mr. Romanelli who brought this up. Again, there was back and forth conversation and Mayor Tamburino finally said, this was the end of the conversation or he would have Mr. Romanelli removed. Mr. Romanelli took his seat.

Janet Dubsky, 452 High Ridge, thanked the Mayor, Village Board, Police, Fire, Public Works departments along with the EMA for a great job this past weekend for Autumn Fest. Everyone had a good time. She said, in her opinion, Hillside is a great place to live.

As there were no further comments, Mayor Tamburino entertained a motion to close the Public Comment portion of the meeting.

So moved by Trustee Kramer, seconded by Trustee Johnson All voting aye, motion carried.

Mayor Tamburino responded to the comments saying the meeting on Friday, October 14 is to formulate a new Senior Social Club. This was being put together when the pandemic happened. Mayor Tamburino added that if he thinks he is breaking the law, to sue him. Mayor Tamburino added, this is not a political meeting and this is why the meeting has been restricted on age.

Mayor Tamburino said if Mr. Aguirre wants to meet Representative Welch, he will be happy to make an appointment with him and meet with the Representative in his Westchester office.

Mayor Tamburino said the meeting on Friday is to get the seniors together. Jan O'Connor is the coordinator of Senior Services. She will be there to help and guide the seniors.

Regarding the meeting Mr. Romanelli mentioned that took place on May $14^{\rm th}$ was the annual Martin Luther King breakfast. We normally have this in January and we bring in guest speakers. Every year someone is going to be handing out some kind of literature outside the building.

Mr. Aguirre said the flyers were only in English not in Spanish. Mayor Tamburino said this was an oversight and we are working on an affordable way to have our newsletter in Spanish and English.

He continued saying we are very fortunate in Hillside to have four hotels of which we collect a hotel tax that enables us to have different events.

Trustee Watson said that as Chairman of the Public Safety and Education committee the officers in the photo were not on duty, they volunteered and came in on their own time to take the photo.

Clerk Gould administered the Oaths of Office to Oaths of Office to new Police Officers, Brandon Martsolf, Ryan Nickel, Robert Campagna and new Firefighter/Paramedic Connor Lowman. Firefighter/Paramedic Emilio Martinez was not able to attend due to illness.

Mr. Romanelli left the meeting at this time.

Clerk Gould reminded online voter registration is available on the Cook County Clerk's website, cookcountyclerk.com. until Sunday, October $23^{\rm rd}$. The last day to register in person at the Hillside Village Hall is tomorrow, Tuesday, October 11, 2022.

Clerk Gould also reminded Mail Ballot applications for the November 8, 2022 election are available at the Village Hall and online at cookcountyclerk.com. Completed applications must be received at the Cook County Clerk's Office by Thursday, November 3, 2022.

Clerk Gould reported Early Voting is October 24 - November 7, 2022, nearest polling places are the Village of Bellwood, 3200 Washington, or Village of Melrose Park, 1000 N. 25th Avenue. Clerk Gould also reported mail ballot drop boxes will also be available at the Early Voting locations from locations October 24 - November 7, 2022.
