VILLAGE ADMINISTRATOR: (Russ Wajda)

Administrator Wajda reported gave an update on legislation actions in Springfield.

 House Bill 267 would be prohibition against residential inspections. This would preclude us from doing time of sale inspections. The only time we could do inspections would be if there was a subpoena or arson investigation.

- House Bill 308 would be changing the formula to fully fund the Police and Fire pensions. This would add 10 years to fully fund the pensions.
- House Bill 315 would be the restoration of Local Government Distributive Fund.
- House Bill 340 would allow for recalls of local government officials.

Administrator Wajda said he will keep everyone posted on these bills.

Administrator Wajda also reported included in the packet tonight is a request from Hillside Lumber requesting Class 6B Classification for their property. Administrator Wajda is working with the property owner and their attorney to get together some information that should have been included with the request. This would need to be approved by the Village Board and then the Cook County Board.
