Mayor Tamburino gave background information on Dynamic Engineering, our largest business in Hillside, that has purchased the old Levitz furniture store on Mannheim Road. They are a manufacturing firm that has grown over a number of years. They rebuild military vehicles and then ship the vehicles back to where needed.

They now have received contracts from Ford, GM and possibly Chrysler to handle their products. They bought the 180,000 square foot building on Mannheim Road and have hired approximately 250 people to date. We are glad to have them in Hillside.


